Contest is limited to one entry per person. Contest entries are focus on the choices we make in regard to plastic, how plastic impacts not only wildlife, but humans as well, and what we all can do to help keep our oceans clean. Entries are to include Petunia Garner™ or Echo the Squirrel™, or a combination of both characters, in a written, drawn or photographed format. Entries containing any reference to alcohol or nudity, or which appear to be inappropriate, indecent or obscene, as determined by Reaping Nature Educational Outreach Foundation, Inc. ("Sponsors"), in their sole discretion, will be judged ineligible. All submissions become the exclusive property of Sponsors, and none will be acknowledged or returned.
